THE CHALLENGE

The client was developing a portable emergency oxygen delivery device in an easy-to-use package. The intention was to create a portable alternative to high-pressure oxygen cylinders, oxygen concentrators, and liquid oxygen, none of which are suitable for highly populated buildings or public spaces. The client's primary challenge was finding the right materials to isolate the chemical components for the oxygen-producing reaction and also safely contain the reaction itself.

THE SOLUTION

The client's injection molding vendor recommended Formerra as a source for the material selection. Formerra's team of materials experts worked with the client to understand critical requirements: regulatory compliance, ingredient separation, reaction management, temperature resistance, reliability, aesthetics, and portability/weight. Formerra offered unbiased recommendations for materials that could safely handle the chemical reaction, which included PC, HDPE, PC/ABS, and color concentrate, and met needs for user-friendliness.

The client was looking for secondary sources for the button and body and base plate of their drug delivery device, one of their most critical products. Ideally, the new material would be a direct replacement with the same shrinkage as the incumbent material. The client had over 1000 molds in use and couldn't redesign or replace them all to accommodate a different material.

THE SOLUTION

Formerra provided a preliminary recommendation for a material that is as close to a direct replacement as possible. Formerra also worked with client and supplier teams to coordinate regulatory documents and a trial plan with a molder.
